Permission has been accorded for opening of **AKRG Elementary (EM) School, Nidadavole, Nidadavole Mandal, West Godavari District** for Classes I to V in the orders 4th cited.

The Correspondent, Sri Alluri Krishna Rao & Govindamma Educational Society, Nallajerlla has applied for according Provisional Recognition to **AKRG Elementary (EM) School, Nidadavole**. The Inspection Officer and Mandal Educational Officer, Nidadavole has verified the application for provisional Recognition with reference to the conditions laid down in the references cited and caused inspection and submitted his report.

After careful examination of the proposals from the society and the Inspection report of the Inspecting Officer and also rules in force in the references cited, provisional recognition is here by accorded to **AKRG Elementary (EM) School, Nidadavole, Nidadavole Manal** with classes I to V (English Medium) for the period from 2018-19 to 2027-28 without aid in subject to the following conditions.

- 1.that the permission/recognition accorded is valid for mentioned school build, Address, classes, medium and period only. If the school building and/or other classes and/or medium opened without proper permission from the competent authority, the permission/recognition will be cancelled without prior notice.
2. that the society shall abide by the instructions, rules and regulations made by the Government and /or District authority from time to time.
3. that the Educational Institution shall serve the needs of the locality more particularly and shall adopt the curriculum and syllabus prescribed by the Government from time to time.
4. that the school timings, vacations and mid-term holidays shall be maintained as prescribed by the Government and /or District authority from time to time.
5. that the qualified staff, within the age limits and qualifications prescribed by the Government for Government Employees shall be followed and shall be appointed as per the staff pattern and should be provided sufficient facilities and the results of the institutions shall be satisfactorily every year.
6. that the Records, audit reports, administrative report and list of Governing body of the Educational Society shall be furnished to the District Educational Officer, West Godavari, Eluru every year 30th September at the latest.
7. that the pay/fee structure fixed by the Governing Body shall be got approved by the District Educational Officer, West Godavari, Eluru every year.

- ...time to time which are not specified in these orders shall also be complied with.
9. That the school shall not be closed without giving notice both to the portents and District Educational Officer/Competent authority at least 6 months before and the personal will be given to close the school only from the date on which summer vacation is declared.
 10. That the society shall submit the proposals for renewal of temporary recognition in the proper manner in advance i.e., at least 6 months prior to the date of expiry of the present recognition.
 11. That the management should submit the register lease dead within six months otherwise the provisional recognition should be cancelled from the year 2018-19.
 12. That the management should not ask any grant from the Government or Department now or in future and that corporal punishment should not be awarded to the children and abide to the Child Rights without fail.
 13. In any deviation on the specified conditions herein and also the Government orders from time to time action will be taken to cancel the Recognition.
 14. That the management should submit structural soundness certificate every year before opening school.
 15. That the management should submit Renewal of Fire Certificate every year.

High School, Ndidavole, Nidadavole Mandal, West Godavari District during the year 2018-19 in proc File.No. RJDSEK-ADMNOPUAE(A2UA)/62/2018-SA-A2, Dated 25.02.2019 of the Regional Joint Director of School Education, Kakinada in the reference 5th read above. The Correspondent has submitted the application for Provisional Recognition for the classes VI to X (E.M) in the school for the years from 2018-2019 to 2027-2028 through the Deputy Educational Officer, Tadepalligudem in the reference 7th read above. The District Educational Officer, West Godavari, Eluru has verified the application for Provisional Recognition with reference to the Inspection Report of the Inspecting Officer and as per the G.O.Ms.No.1 Education, Dt.01.01.94.

Under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Kakinada, competent authority for Secondary Schools hereby grants Provisional Recognition for a period of 10 (TEN) years i.e., from 2018-19 to 2027-28 for the classes VI to X (E.M) as recommended by the Deputy Educational Officer, Tadepalligudem and the District Educational Officer, West Godavari, Eluru subject to fulfillment of the following conditions in A.K.R.G. High School, Ndidavole, Nidadavole Mandal, West Godavari District.

That the society shall abide by the instructions / rules and regulations made by the Government or authorized Officer from the time to time.

1. That the Educational Institutions shall serve the needs of the locality more particularly.
2. The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
3. That the school timing vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
4. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern
5. That the results of institution shall be satisfactory every year.
6. That the records / accounts shall be furnished to the District Educational Officer, every year by 30th September at least.
7. That the list of Governing Body shall be furnished to the District Educational Officer every year.
8. That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
9. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with.
10. That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before.
11. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
12. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expire of the present recognition.
13. That the society shall provide fire safety measures in the school as per the No Objection Certificate.
14. The management informed that no thatched roof accommodation is allowed to run the School.
15. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students
16. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
17. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments
18. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children
19. The school shall have first aid kit and the teachers shall be trained in first aid
20. The Correspondent of the concerned school is hereby informed to file an affidavit to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
21. That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail
22. That the management shall ensure the Accountants of this school audited by an authorized Chartered Accountant every year and submit.
23. That the management has to maintain trained teachers at all time
24. The management is informed to follow the guidelines issued in G.O.Ms.No.91 Education, Dated.06.08.2009 regarding Fee Structure in Private Schools.
25. That the Management of the school is informed that, these orders are issued subject to conditions that, to obtain and submit the occupancy Clearance of fire issued by the concerned department within the stipulated dates mentioned in the order and submit to this office through the inspecting officer concerned for the entire period of recognition without fail. If the management fails to comply with the above conditions promptly, the Recognition now granted will be reviewed.
